If, in the sole opinion of the Company, a product covered by this warranty is defective, this warranty is limited to the repair and/or replacement of the product. This limited warranty shall extend for a period of FIVE (5) years following the date of supply. The Company shall not be responsible or liable for consequential or incidental damages resulting from any defect in the product supplied.

In the event of a defect, the Company shall repair and/or replace the defective material provided the following conditions have been satisfied:

1. *You shall notify the Company, in writing, that the product has become defective, stating the nature of the defects within the warranty period; and*
2. *You shall permit the Company, its agents and employees access to examine the product after notification so that the cause of the problem can be determined and repairs or replacements made.*
3. *All maintenance procedures recommended by the Company must be followed and documented to ensure warranty validity.*

EXCEPTIONS

Excluded from the terms of this limited warranty are the following:

1. *The Company shall not be liable and responsible for consequential or incidental damages.*
2. *The Company shall not be liable for damages caused by unusual, extraordinary or unforeseen conditions.*
3. *Any repair work or alteration of the product not done under the supervision, or subject to the approval of the Company, shall void any liability under the limited warranty.*
