

When a longitudinal recess blockout is required to contain an architectural joint system, increase the concrete floor assembly thickness to maintain a min. thickness of 6 in. and accommodate depth of blockout formed in the concrete: blockout width unrestricted.

treatment in accordance with manufacturer's installation instructions.

- A. The 1 in. and 2 in. nominal joint widths require only one layer of ceramic blanket.
- B. The ceramic paper is adhered to the joint face of the concrete floor assembly (Item 1) using a single, nom. 3/8 in. wide bead of Tremco Trempro 644 high temperature silicone sealant. Strips of foil tape are used to hold the ceramic paper in place while applying the sealant and while the sealant cures per the manufacturer's instructions. The tape may be removed after the sealant cures, or it may remain in place.
- C. Splices in joint treatment should be implemented by offsetting the individual component layer splices by minimum of 12 in. and should be installed per manufacturer's installation instructions.
- **3. JOINT COVER:** Min. 20 GA joint cover formed of aluminum, bronze, stainless steel, or galvanized

steel. Joint cover splices shall be offset from splices in joint treatment layers below by minimum of 12 in. and the splice shall be butted together.

(Not Shown): In conditions where the linear opening is enclosed within a chase wall, a joint cover consisting of a creased 2 mil stainless steel foil secured with 1 in. wide continuous galvanized steel washer strips along each side of the joint may be installed in lieu of the min. 20 GA joint cover.

4. FASTENERS: Joint covers (Item 3) shall be anchored to concrete floor assembly (Item 1) with min. 3/16 in. diameter concrete anchors at max. 18 in. oc over length of joint in accordance with manufacturer's installation instructions.
